04. FIRST – AID MEASURES

EYES: Irrigate copiously with clean, fresh water for at least 15 minutes. Seek medical advice.

10. STABILITY AND REACTIVITY

The product is stable in normal conditions of use and storage. In the event of thermal decomposition or fire, vapours potentially dangerous to health may be released.

Propylene glycol: it is hygroscopic, stable at normal conditions; at high temperatures, it tends to oxidize yielding propionaldehyde as well as lactic and acetic acid.

11. TOXICOLOGICAL INFORMATION

Acute effects: stinging eyes. Symptoms may include rubescence, edema, pain and lachrymation. Vapour inhalation may moderately irritate the lower and upper respiratory tract and cause cough and respiratory disorders. At higher concentrations, it may also cause pulmonary edema.
